Mr. Fung has been called as the Interim Pastor of Journey Evangelical Church of Westminster, effective June 9, 2011, for a period of up to nine months and renewable at that time. Mr. Fung may not be considered for the position of installed Pastor.
GABRIEL FUNG	Dr. Keith Geckeler, Stated Clerk, introduced Candidate Gabe Fung. Gabe was invited to share his faith journey. Vice Moderator Kirk Winslow opened the floor for examination. After a time of examination, it was M/S/P to arrest the examination and Gabe was excused from the room.
